I am applying for the Career Advancement and Research Excellence Support (CARES) Award to cover care giving expenses while I complete a grant and travel out of the country for a Molecular Biology Conference in South Africa June 23 -28, 2023 and future professional certifications to further my career in molecular biology. My current research is highly dependent on this grant submission, as it will provide me to the funding necessary to expand my research and gain access to new collaborators. As a result, I need protected writing, research, and meeting time outside of my normal schedule.

As the only child of sick elderly parents, I am their primary caregiver and coordinate my schedule around their needs. I have structured my lab time around their schedule. On days that I am in the lab, typically Monday, Tuesday, and Wednesday, I hired a part time home aide at \$22/hr to care for my parents from 9am – 5pm, for the weekly cost of \$528. Extending my home aide's services to cover additional research time needed for grant preparation and six days of full-time care, while out the cover, would raise my care giving expenses to nearly \$2500 for the month of June. Without the financial support of the FASEB CARES Award I would have to miss the conference, as I have done in the past, because I did not have the financial resources to cover both international travel and afford full-time home aide care for my parents.

Having the financial support of the CARES Award would allow me to make additional future career development plans without weighing costs and sacrificing time away from caring for my parents. To be truly competitive in the field of molecular biology and strengthen my clinical applications skills, I plan on pursuing the American Board of Clinical Cytogenetics (ABCC) certification. This certification can range from 1000-2000 in cost and requires a 6 month-1 year time commitment. Without the CARES Award, I would be unable to cover the full costs and time commitment necessary to advance my career.
